# HOW TO GET

*Involved*

What you can do to get the greatest benefit possible for your membership dollars. The answer is get involved!

- **Builder/Developer Council** is an industry council which addresses issues specific to builders and developers. They are a pro-active industry advocate in all local elections, appointments, and legislation. Together they monitor industry trends, government policies regarding economic development and growth. They develop strategies to improve image and communicate progress, share information on how to handle common problems and issues, build solid relationships with governing bodies and related groups. All members are welcome to attend the meetings scheduled on the **2nd Tuesday of the month at 3:00 pm.**
- **Associates' Council** sponsors activities that educate and/or entertain the membership; and enhance recognition and appreciation between builder and associate members. This includes planning and implementing directives through regular monthly meetings. Their main fundraiser is our Clay Shoot. All Associate members are invited to be members of the Council. An Associate member is any member which is not a builder, developer, or remodeler; i.e., building supply, real estate, insurance, carpet, window, landscape, etc. Most Associates Council meetings are held on the **first Wednesday of the month** and hours vary as they are usually hosted offsite by an Associate Member. - **Professional Women in Building Council (PWB)**. Membership in this Council is available to BCASWI member-company employees for a cost of only \$75 per year. The BCASWI Professional Women in Building Council is tied to the national council through NAHB. The NAHB Professional Women in Building Council is the premier professional organization that provides strategies and solutions for professional women in the building industry. Through various publications, awards, scholarships, seminars, and programs, they provide women in the building industry the professional advantage necessary to excel and succeed. Members also receive well deserved recognition for their contribution made to the home building industry and home ownership. In construction, spikes are essential to shaping our buildings and making them strong. In building a strong association, Spikes are priceless. A spike is a member who works to recruit new members, get members involved and retain members.

WHAT IS A SPIKE? Spike Club members are the true champions of NAHB. By recruiting, involving and retaining members, Spike strengthens and builds both our association and the entire industry.

Becoming a BCASWI/NAHB spike has its exclusive awards, including these benefits:

To achieve spike status you must earn six credits within two consecutive membership years (November 1 - October 31).

To retain spike status and become a Life Spike, you must earn a minimum of one Spike credit (new or retention) each membership year until you reach a total of 25 credits. Spike credits are earned by recruiting and retaining members. NAHB recognizes and rewards your membership development efforts with its spike club awards program. Awards are earned beginning with six credits and at increments of 25, 50, 100 etc. until the All-Time Big Spike level is achieved at 1,500. At the 50d, 100d, 150d and 250d levels you will receive several distinctive awards.
